IASC Foundation and IASB launch new Website

The International Accounting Standards Committee (IASC) Foundation and the International Accounting Standards Board (IASB) have launched their new Website, which can be accessed at either www.iascfoundation.org or www.iasb.org. The new Website features a new 'look' and 'feel' and provides users with more information than ever before.

Highlights of the new Website include:

- the home page gives a list of the latest news, events and forthcoming meetings
- an easy-to-navigate drop-down list of each of the most popular sections on the Website—no section is more than three clicks away
- an improved 'Current Issues' section that lists all current projects of the IASC Foundation
 (such as its Constitutional Review), the IASB and its interpretative body—the
 International Financial Reporting Interpretations Committee (IFRIC), and provides links
 to comment letters received for archived projects
- A 'Resources' section that provides information on services such as education and conferences
- A 'new look' IASC Foundation Bookshop.

Subscribers to the Comprehensive Subscription Service will also have access to:

• all International Financial Reporting Standards (IFRSs), which include International Accounting Standards and Interpretations, both in electronic (HTML) format and as Adobe Acrobat '.pdf' files, back to 1 April 2001. Subject to verification of the contents, which is now in hand, the IASB intends to designate the HTML format as the preferred up-to-date authoritative text of the IFRSs. In the meantime the '.pdf' files are to be preferred.

a powerful new 'Search Standards' function that allows searching by issue date and

effective date

an 'IFRS History' section that will link all versions of any given standard back to 1 April

2001, when the IASB began operating.

a new Comprehensive Subscription Service area that organises files by topic

• the most recent translations of IFRSs in several major European languages.

The launch of the IASB Website is the first of two phases of Website enhancement. During

the next phase—due to be completed in the first half of 2004—the IASC Foundation Shop

will be upgraded to accommodate new products and services. This upgrade will also enable

orders for goods and services to be fulfilled and dispatched more promptly than before.

The IASB is continuing to experiment with Webcasts in an effort to make Board meetings

more accessible to interested parties located throughout the world.
