# IASC FOUNDATION TRUSTEES NAME STANDARDS ADVISORY COUNCIL TO PROVIDE ADVICE TO IASB

The Trustees of the International Accounting Standards Committee Foundation announce the appointment of the Standards Advisory Council (SAC). The members of the SAC will be asked to provide advice to the International Accounting Standards Board (IASB) on priorities in setting standards. It will also inform the Board of implications of proposed standards for both users and producers of financial accounts.

The 49-member body includes chief financial and accounting officers from some of the world's largest corporations and international organizations, leading financial analysts and academics, regulators, accounting standard setters, and partners from leading accounting firms. The members of the SAC are drawn from six continents, 29 countries, and five international organizations. Additionally, the European Commission, the U.S. Securities and Exchange Commission, and the Financial Services Agency of Japan will participate as observers.

Paul A. Volcker, Chairman of the Trustees and former Chairman of the U.S. Federal Reserve Board, emphasized, "The goal of our organization is to produce a single-set of universally accepted, high quality accounting standards. Having a broad range of expertise and experience represented on the Council, which is expected to meet several times each year, will help ensure both the quality and the practicality of the work of the Board."

The first meeting of the SAC with the IASB will occur in London on July 23-24, 2001.
